Neighbor Ride will decrease isolation and improve the quality of life for Howard County's older residents by providing a reasonably priced, reliable supplemental transportation service which utilizes community volunteers and resources.



PRESIDENT'S MESSAGE

We've had another successful year at Neighbor Ride! Thanks to the gifts of time, energy, and resources provided by a great group of volunteers, we're not only surviving the economic downturn, we've been able to expand our capacity to serve Howard County's seniors.

In the last year, we provided 7,903 trips for seniors in the community representing a 33% growth over the prior year. In total, Neighbor Ride has provided nearly 30,000 trips for passengers since beginning operation in November 2004. Two hundred twenty new passengers registered in FY10 and eighty-six volunteers were recruited.

In 2009, we chose to focus on "becoming a household name" in Howard County as one of our strategic goals. We're proud to be well on our way to living up to the reputation we have achieved with our passengers and others in the community. I'm pleased to report that we were once again voted Best of Howard Charity/Non-Profit by the readers of Howard Magazine and were honored with awards from the Horizon Foundation, the Howard County Commission on Aging, the Beverly Foundation and Home Instead Senior Care. Each of these awards was a wonderful acknowledgement of the hard work and commitment of our staff and volunteers.

We've formed our first business partnership with 1st Mariner Bank, which sponsored our 5th Anniversary Celebration and provided the funding needed to replenish our car door magnets, a critical tool in helping our seniors know that the driver serving them is a Neighbor Ride authorized driver.

Looking forward, our attention will be on capacity – we need both the volunteers and the resources to keep up with our growing demand. As our population ages, we expect that our passenger base will continue its steady climb, and our challenge will be to keep resources aligned to meet the needs of an ever larger group of Howard County seniors who depend on us for their transportation needs.

Neighbor Ride remains committed to a future of improving the quality of life for the county's older residents by enabling them to remain mobile, active and independent.

On behalf of the Board of Directors, the staff, our wonderful volunteers, and everyone associated with Neighbor Ride, I am proud to present you with this Annual Report.
